CHANGE IN POLICY

You soon will be receiving a SurveyMonkey to vote on a change to the following Policy. The change has been made to allow Members to pay their bill through an e-transfer. There also is a change to the date for the final payment.

9. b) Members will be invoiced as follows:

Full Member

An invoice with all charges pertaining to Membership Fees and Charges will be sent to Full Members as soon as possible following ratification at the Annual General Meeting. The invoice will be based on the previous year's dockage and storage usage. Any changes in usage of club facilities (dockage and/or storage) will be charged or credited as they occur.

Within thirty (30) days of the date of the invoice, Full Members will be required to pay this invoice in full or **one-third of the amount shown on the invoice to be paid on each of the following dates - January 15, March 15 and April 15.** ~~provide three (3) post-dated cheques, dated January 15, March 15 and May 15, each equaling one-third of the amount shown on the invoice.~~ **Payment can be made either by cheque or e-transfer.**

A Full Member who has not paid their invoice in full **by April 15** ~~or provided three (3) post-dated cheques within thirty (30) days from the date of the invoice~~ will be deemed in arrears. Interest will be charged from the date of the invoice on the outstanding amount of the invoice.
